Life Principles Academy (LPA): Conducted eleven 4.5 hour training courses on college and university campuses across the United States, graduating 123 students (our highest graduate number since inception of the program). In 2024, we also scripted and filmed 14 new episodes of "Truth in 90 Seconds" to be edited and released in 2025.
